This was to celebrate the 150th anniversary of St Joseph being declared the Patron of the Universal Church. To join in these celebrations the Diocese has produced a Novena to St Joseph leading to his feast day 19th March. The Novena takes as its focus the different groups or causes that claim St Joseph as their Patron Saint, as well as the themes of Pope Francis' letter launching the year. ## **Dear parishioners**

Many of you have contacted the parish about the financial situation during this difficult time to find out how you could continue to help financially. This concern has been very moving and much appreciated. May I say that although the pandemic has impacted us in a financial way as well as in many other ways we are coping and will continue to manage so please do not feel bad in any way if you have not been able to keep up your normal level of support. This is fully understandable.

As you know the first lockdown happened in late March 2020 which was the very week when we would normally have been reporting to you about the results of collections and Gift Aid for the year to March 2020. We would also normally be requesting information about changes of address and tax status and finding out if anyone new wanted to gift aid their contribution to church funds.

We were not able to do any of this of course and nor could the envelopes be properly distributed. This is not a problem for a single year but we do need to decide what to do for the financial year beginning on April 11<sup>th</sup> and for which the new envelopes have now arrived. Jim Howell, our gift aid coordinator will be contacting you to review things like address and tax status and to learn if you can continue to Gift Aid your contribution. He will also be able to provide information to those who may want to consider giving by electronic means rather than in cash. We have all noticed the dramatic reduction in the use of cash this year and expect this to continue.
